

Agility Rush Ring Rental Agreement



This agreement is for rental of the Agility Rush K9 Sports Center (Agility Rush) at 237 River Rd, Uxbridge MA 01569 training facility, 60x90 on GrassTex True Turf with use of all equipment in the facility.

Equipment: All equipment for running a standard agility course will be maintained in good condition and is available for use. If there is any damage incurred during usage the facility manager Dale Levitt (508-439-0347) will be notified via phone call or text.

Rental Time: Rental time includes any set up or take down of equipment prior to use. Please do not arrive before your scheduled time. Reservations for ring rentals will be confirmed 24 hours prior and a code will be provided for access to the key lock box. The code will be valid for your rental time only.

Building Use: The building will be left clean in the same manner to which it was found. Shoes should be clean and dry before walking into the arena. No food items shall be consumed on the Turf. Food reinforcement can be used for training but please avoid crumbling treats or treats that may stain the turf. Any use that requires significant clean up (i.e dirt or debris, food material, blood, fecal or urine staining, etc) will incur a \$50 fee. Please notify us of any areas that require clean-up. Instructions for clean up will be posted in the building. All accidents on the turf must be cleaned immediately and the turf clean up fee (\$25) paid to Agility Rush.

Liability: I understand that I (and any additional parties accompanying me) am participating in this activity at my (our) own risk. Dog training contains certain inherent risks and injuries may happen even when handled with the utmost care. I assume full responsibility for the dog(s) that I am participating with. I assume full responsibility for any damage or injury to the person(s) or other animals caused by myself or said dog(s). I assume full responsibility for any injury that I, or said dog(s), might sustain as a result of participating in this activity. I understand that any animal or human entering the property runs the risk of contracting any communicable diseases. I acknowledge that Agility Rush will hold no liability or responsibility. The facility will be maintained in working order and provide a safe, comfortable, and well lit environment for training.

Termination of Agreement: The breaking of any rules outlined above will result in termination of this agreement. Agility Rush reserves the right to end renter access at their discretion.

Cancellation Policy: If canceling 24 hours or less from your rental time, 50% of the fee will be charged. There will be no charge for the rental if canceling due to acts of god or any extenuating circumstances determined by Agility Rush.

Waiver for Damages and/or injury: I/we waive and release any agent of Agility Rush of any and all liability and claims of any nature for the property damage or injury, including death, suffered by any parties resulting from the action of any dog, or equipment, even if caused by alleged negligence. I solely claim responsibility for such damage, illness or injury while renting the agility ring, or while being on the property or surrounding area.
